Safety Regulations

- Federal regulations
 - Federal register – searching
- Code of Federal Regulation
 - Title 10, 21, 29 (CFR 1910, 1926, 1960), 40, 44, 49
- OSHA
 - 29CFR 1960 – Federal agency requirements
 - Army will comply with 1910, 1926 per AR 385-10
- Air Force has AFOSH
- Navy has NAVOSH

OSHA Violations

- Serious violation
 - As a rule all DOD violations are serious or greater
- NOV issued to the installation or activity
- No fine
- NOV's go to agency safety and occupational health official
- Must abate –
 - JCAHO now looks at PFI's with specific time frame for abatement – if you fail to abate by ECD then a waiver must be granted from JCAHO
- OSHA Form 300
 - Army will now comply with 1904,- IAW 29CFR 1960 –
 - MEDCOM has automated system and modified OSHA 300
 - 1 Jan 2002 must not show names for certain injuries/illness; needle sticks show type of device, activity being performed when injured and show if using safety device
 - JCAHO will look for trends and performance activities
 - Quarterly briefing to SOHC
 - Annual report to governing body
 - Is the organization improving, did you meet your goals for the prior year and show goals for next FY
 - Injury/illness report is posted February each year through 30 April
- Don't forget Measures of Merit per DODI 6055.1 – Military fatality rate; Class A accident rate for aircraft; civilian lost-time injury rate (based upon DOL FECA claims)

FDA

- FDA approves prescription and over-the-counter drugs, including

labeling requirements.

- Food, drug and cosmetic act
- Fair packaging and labeling act
- Radiation Control for Health and Safety Act relates to electronic products such as lasers, x-rays, and microwaves
- Medical Device Regulation
- Procedures in place to obtain, evaluate, and take corrective action in all situations concerning hazardous equipment, drugs and food substances
- Safe Medical Device Act (SMDA)

Training

- Ongoing monitoring of performance regarding actual or potential risks related to one or more of the following:
 - Staff knowledge and skills
 - Level of staff participation
 - Monitoring and inspections activities
 - Emergency and incident reporting and
 - Inspecting, preventive maintenance and testing of equipment and
 - Emergency procedures that address
 - Facility-wide fire response needs
 - Area-specific needs and fire evacuation routes;
 - Specific roles and responsibilities of personnel at a fire's point of origin
 - Specific roles and responsibilities of personnel away from a fire's point of origin
 - Specific roles and responsibilities of personnel in preparing for building evacuation
- NOTE: each element has the same requirements for monitoring of performance and specific guidance for emergency procedures i.e. HAZAM must address emergency procedures that describe the specific precautions, procedures and protective equipment used during HAZMAT/waste spill or exposures.
- Training requirement vary with activity/mission
 - Fire protection (life safety) EC standard
 - HAZMAT – EC standard
 - Accident reporting and investigation – EC standard
 - Slips, trips, falls, lifting safety, formaldehyde and other chemical exposures
 - PPE – OSHA
 - Biological hazards (blood borne pathogens) –OSHA
 - Laboratory safety – CAP
 - Radiation control – NRC
 - Equipment safety – EC standard
 - Emergencies/disasters (internal and external) – EC standard
